A substitution can be made **in place of one** of Standard Menu items, FOR ADDITIONAL COST, with one of the following:

In the Standard Menu are included the following: mashed potatoes or rice pilaf, tossed salad, bread, coffee, linen table cloths, linen napkins, plates and silverware, plastic cups for drinks. Soft drinks are part of the Standard Menu and are provided at a price of \$0.25/person. It is **prohibited to bring in from outside any sort of soft drinks**, no matter what their packaging.

The Person / Organization renting the hall(s) has the option to add to the dishes in the Standard Menu, ANY of the dishes listed below FOR ADDITIONAL COST, as follows:

NOTE: Small Hall is not available for rental for less than 75 people.
Large Hall is not available for rental for less than 150 people.

Person / Organization renting the Hall(s) must:

1. Provide their own plates, silverware, napkins, and bread for appetizers.
2. Bring the desert arranged on trays suitable for refrigerator storage.
3. Provide their own floral arrangements on tables.
4. Purchase the beer from church.
5. **Mandatory hire the bartender** from Church (Cost: \$100).
6. **Mandatory hire the security** from Church (Cost: \$100).
7. Acknowledge that meal service cannot start after 9:00 PM.
8. Acknowledge that table cleaning cannot start later than 11:00 PM.
9. Acknowledge that, in accordance with Michigan State Law, the bar service ends no later than 2:00 AM.
10. Acknowledge that closing of Hall(s) is not later than 3:00 AM.
11. Acknowledge, and inform the their invitees, that **smoking is prohibited** inside the entire Hall building. **Smoking is only allowed at the special designated place, outside the Hall, near the South entrance.**
12. Acknowledge that food preparation using Church's kitchen is prohibited.
13. Acknowledge that entrance in Church's kitchen or freezer rooms is prohibited.
14. Acknowledge that altering the walls, ceiling or entrance doors is prohibited.
15. Not use confetti on the table cloths.
16. Not use ice sculptures or chocolate fountains, etc.
17. Not seat more and no less than 10 persons per table (according to the Decision of Church's General Assembly).

The Hall deposit paid for Hall(s) rental is NON-REFUNDABLE.

This Contract, signed between Descent of the Holy Ghost Church and Person / Organization is the official legal document recognized by the State laws and must be respected by all parties signed below, to avoid any possible misunderstandings.

The person signing this document is responsible and has the obligation to close the bar and evacuate the Hall(s) by the hour specified in the present Contract. The person is bound to pay for any damage caused by to the invitees; not obeying the present Contract may lead to the payment of fees.
